And because we serve thousands of consumers with a broad range of needs, when we're asked, "What does life without limits mean?" our answers aren't always what people expect to hear.

For 26-year old Richard, life without limits means leaving town without his parents for the first time. And for Candy, 54, life without limits means going Christmas shopping or out to eat with her friend.

"That's it? She goes shopping? He left town? That's a life without limits?"

Yes. For people with disabilities, that is a life without limits.

Now more than ever, UCP Seguin Foundation is advancing the conversation about life without limits so our supporters truly understand the varied needs of all of the people impacted by the programs we fund.


As institutions shut down across the country, we're serving more consumers who need our help by funding grants for state-of-the-art training systems to improve staff skills. Through our Assistive Technology Exchange Network (ATEN) program, we've obtained funding to provide refurbished computers to more than 12,000 children with disabilities in 565 public schools throughout Illinois. We've secured 24 iPads for consumers to use in community settings as well as replaced 60 outdated computers for UCP Seguin program and support staff.

And, yes. We funded an expansion to the community based learning experiences for our consumers - the very ones that create opportunities for Candy to go shopping or out to lunch with her friend.



For Janice L. Stephens, a teacher at Cahokia District #187, ATEN provided the up-to-date technologies needed for her special education students, as Illinois lags behind in providing services to disabled students.

Miriam and Juan's father know that his children would be bored and depressed without the Recreation Club. With limited personal resources, Mr. Guerrero sees the opportunities Rec Club provides that wouldn't be possible otherwise.
