Last year we had an unprecedented start on planning for our 28th Annual Great Chefs Tasting party. But like many in our position, COVID-19 forced the cancellation of that fundraiser. It did not, however, cancel our commitment to fund programs for people with disabilities at every age and stage of life.

Our recent efforts have generated funds primarily for Infinitec – an assistive technology program that leverages the power of technology to advance independence and promote inclusive opportunities for children and adults with disabilities. So when our consumers found themselves in the digital divide – self-isolating at home without internet access or a computer – the Infinitec Team stepped up to:

- develop a Paraprofessional Professional Learning series, to impact student outcomes when in-person learning resumes
- work with social workers to help families receive hospital beds, commodes, walkers,
   Hoyer lifts, diapers, wheelchairs and bath benches when medical supply companies were overwhelmed with orders from healthcare facilities during the pandemic
- ensure that parents, teachers and students had both the equipment and Internet access to elearn and stay connected at home

While this annual report necessarily looks back, the Foundation is also very much looking forward. We look forward to connecting with you again – hopefully at our next Great Chefs Tasting Party, and otherwise through our annual giving and other campaigns. We look forward to continuing our support of programs focused on leveraging technology and other assistive devices towards leveling the playing field. And we look forward to advancing the Foundation's mission to help persons with disabilities achieve their potential, advance their independence and act as full members of our communities.
